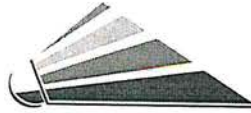

d. Statement on behalf of nominee on how he / she can assist Badminton Pan Am Confederation.

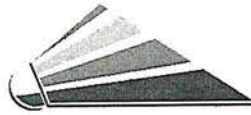
My main support is based on 4 main axes or pillars that are 1.- Good Governance (Good governance is both a necessity and an obligation for the different associates to grant credibility and respect to this autonomy), 2.- The Strengthening of support and training programs for coaches and judges (We must reinforce the continental base of our sport in order to advance more evenly and solidly in our continent), 3.- Rapprochement between countries and equal opportunities (It is important to create conditions so that all the zones of the Confederation are integrated, each one working under the conditions of their countries, but in an articulated way and that that sense of identity and belonging to the Confederation is generated and to improve the rapprochement) and 4.- The position of the Confederation vis-a-vis to sports Institutions regarding other sports (The idea is that badminton in America, Europe, Aisa, Africa and Oceania is positioned as other sports are in the games of the Olympic cycle, work hand in hand with the BWF, the IOC, Panam Sports, Centro Caribe Sports, ODESUR, CANOC, ORDECA, ODEBO, COMEBA and any other organization that organizes sporting events).


d. Statement on behalf of nominee on how he / she can assist Badminton Pan Am Confederation.


d. Statement on behalf of nominee on how he / she can assist Badminton Pan Am Confederation.
