No late entries will be accepted.

Players cannot be entered unless they already have a BWF ID-number. Since July 2014 all MAs can create their own BWF ID numbers through Online Entry System.

ENTRY FEE:

Cost: €100.00

If entry fee is not paid according to the regulations, the players concerned are not allowed to play.

The member association that enters a player into a circuit tournament is responsible for paying the entry fees for that player. (If entry fee is paid in cash 10% tax will be added)

WITHDRAWALS:

Please ensure that the organizers are informed immediately when a player has to withdraw, together with the reason.

Attention: Any withdrawal after the Sunday immediately preceding the draw, for any reason what so ever, renders the Member Association concerned liable to an amount of \$150,00 for the inconvenience caused by the withdrawal (as defined in BWF General Competition Regulations).

VISA:

Important for all players who need visa for Cuba. Please apply for a tourist card at any travel agency in your country or request an official Invitation letter to Cuba Badminton Federation: calamartinez86@gmail.com / charadanpierre@gmail.com

UNIFORMS:

According to BPAC regulations, for all tournaments that are part of the Pan American Circuit the player's name and the country name or code on the back of the shirt is mandatory. (BWF GCR, referring player's clothing, designs, advertising and lettering)

TRANSPORTATION:

Bus schedule will be set up according to competition schedule for those using the tournament official hotels.

MEDICAL SERVICE:

A doctor and a physiotherapist will be at the venue while matches are on.

DOPING CONTROL:

Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out of competition and in-competition with the collection of urine and/or blood samples.

Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE).

BADMINTON INTEGRITY:

Section 2.4 of the BWF Statutes (Code of Conduct in Relation to Betting, Wagering and Irregular Match Results) relates to anti-corruption and anti-match manipulation, and this code applies to all participants at this tournament.

To protect the integrity of BWF sanctioned tournaments, participants are not allowed to bet in any way on badminton matches, respect the principle of fair play, and shall not attempt to influence the course or result of a game or match.

Every person has an obligation to report to the BWF any approaches by anyone to gather inside information or to change the outcome of a match.
