Attention:

Any withdrawal after the Sunday immediately preceding the draw, for any reason whatsoever, renders the Member Association concerned liable to an amount of \$150,00 for the inconvenience caused by the withdrawal (as defined in BWF General Competition Regulations).

## VISA:

## UNIFORMS:

According to BPAC regulations, for all tournaments that are part of the Pan American Circuit **the player's name and the country name or code on the back of the shirt is mandatory.** (BWF GCR, referring player's clothing, designs, advertising and lettering)

## TRANSPORTATION:

Bus schedule will be set up according to competition schedule for those using the tournament official hotels.

## MEDICAL SERVICE:

A doctor and a physiotherapist will be at the venue while matches are on.

## DOPING CONTROL:

Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out of competition and in-competition with the collection of urine and/or blood samples.

Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE).

any way on badminton matches, shall respect the principle of fair play, and shall not attempt to influence the course or result of a game or match.
