Uniforms:

According BPAC regulations, for all tournaments that are part of the Pan American Circuit **the player's name and the country name or code on the back of the shirt is mandatory.** (BWF Statutes, Section 5.1 GCR 20-24, Player clothing and equipment, referring to player's clothing, colours, designs, advertising and lettering)

Transportation:

FESALBAD: will offer transportation from the airport to the hotel and will offer transportation from the hotel to the venue, only for bookings at the Official Hotel.

Medical service:

A doctor and a physiotherapist will be at the venue during the practices and while matches are on (according to the Pan Am regulations 23.1)











Doping Control:

Doping control in badminton, in accordance with BWF AntiDoping Regulations, is conducted out-of-competition and incompetition with the collection of urine and/or blood samples. Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE).
